HKIoD CPD courses are generally qualified to obtain accreditation from HKICPA, CPA Australia, ACCA, HKICS, Law Society of Hong Kong* and other institutes under Continuing Professional Development Alliance. Final decision is subject to approval from individual organisation and institute. *Advance notice is required, with a lead-time of 1 month to apply for accreditation from The Law Society of Hong Kong.
